PRIMARY CARE NETWORK (PCN) GUIDANCE AND SPECIFICATION

GP TRAINEE INDEMNITY ARRANGEMENTS

The 2019/20 GP contract agreement secured delivery of the state-backed indemnity scheme for GPs in England. Under the scheme, which started on 1 April, all GP trainees placed in GP settings for training purposes will automatically be covered for clinical negligence liabilities - no payments are required to benefit from the indemnity provided.

Following further discussions between Health Education England (HEE) and General Practitioners Committee (GPC) representatives, comprehensive personal indemnity cover for all GP trainees will be funded by HEE until qualification. This includes, for example, support with General Medical Council (GMC) investigations and hearings, assistance with criminal proceedings, protection for Good Samaritan acts, and free medicolegal advice.

Where a trainee's personal protection is currently provided by a medical defence organisation through a bulk-indemnity agreement, this will continue. Those trainees who purchase their own professional cover should continue to seek full reimbursement until such times as a future bulk-indemnity agreement is arranged by HEE.

CONTRACTING ARRANGEMENTS FOR INTEGRATED CARE PROVIDERS (ICPS)

This highlights the concerns raised by the British Medical Association (BMA) during the consultation and proposes to make changes to the contract to increase accountability and transparency of ICP organisations. However, the BMA continues to caution any practice considering this option as the risks to their future contract remain.

LOCUM PRACTICE AGREEMENT

A locum practice agreement developed jointly by the General Practitioners Committee (GPC) and the Sessional GP Subcommittee, with the help of BMA Law can be accessed via:

The agreement consists of Terms & Conditions and a Work Schedule which together form a legal contract that can be used by locum GPs and GP practices for locum engagements. It is intended to:

- minimise common disputes between locums and practices and clearly outline the type of work that will be undertaken by a locum when working at a practice;
- protect against locums being categorised as an employee or worker by HMRC for tax purposes or by an employment tribunal for the purposes of statutory employment protection, as well as ensure that there are appropriate arrangements in place for compliance with General Data Protection Regulations (GDPR).

SUTURE DRUG TARIFF UPDATE

Information submitted by Dr Soon Lim, President and Education Lead, Association of Surgeons in Primary Care (ASPC)

Further to the article in the December 2018 LMC Newsletter, practices which carry out minor surgery and wish to continue to claim for the sutures used need to be aware of the following update from NHS England (NHSE):

Ethicon updated their product codes from February which was reflected in the Drug Tariff and on dm+d. As per usual to allow for the old stock to be depleted, the old codes are listed until May 2019 with an indicator next to them "marked for deletion".

From 1^{st} May the old products will be deleted from the Drug Tariff and their status will change in dm+d to "not allowed in the Drug Tariff". It is possible that the software systems have not been updated since the change occurred and therefore it is not reflected.

These software systems are updated regularly and these changes should be reflected on the GP systems. Unfortunately we would not be able to tell if these new codes are not showing on the GP system of choice, the practices will need to raise it with their system provider, as they manage and control changes and updates. If they don't get any joy from the system provider, NHSE would suggest that they ask NHS Digital to intervene. NHSE are hopeful that this issue will be sorted by 1 May at the very latest.
