- Nomination and voting for this election is governed by conference standing order 74.
- With the exception of those standing for the 'seventh seat', candidates do not have to be a representative of a local medical committee at conference.
- **Nominations may be made only by representatives of a local medical committee at conference.**
- A representative may make ONLY ONE nomination.
- Elections, if any, will take place on the first day of conference and be completed by the start of the afternoon session.
- **Only representatives are entitled to vote.**
- Those elected serve for one year from the conclusion of the ARM.
- The GPC may fill casual vacancies occurring during the year.
