### Local QOF

The LMC were represented at the majority of the recent PCT PMS Quality and Outcomes Framework consultation events. The timetable has been pushed back considerably from what we first feared and we will now have to wait and see what the PCT propose next. Meanwhile practices should continue to look at their own value for money positions as agreed in previous annual commissioning review visits and also to examine their own PMS contracts. ### Summary Care Record

You may be aware that the BMA have issued a press release calling for delay in the implementation of this programme. The electronic transfer of summary care

records is said to be voluntary, with there being no obligation on practices to take part. That said, practices should think through the implications of whether to take part or not.

The GPC have produced their guidance on the rollout of the above across a number of SHAs, which explains: -

- What is the Summary Care Record?
- What is the consent model for the SCR?
- Is the Summary Care Record being rolled out in my area?
- What information will patients receive?
- Should the GP practice play a role in informing patients about the SCR?
- What action should I take if the Summary Care Record is being rolled out in my area?
- Will the Summary Care Record generate extra work?
- How have the BMA and GPC been involved in the development of the SCR?

### **H1N1 Vaccination**

Practices have been advised to continue vaccinating at-risk groups opportunistically beyond the end of March.

For this they will continue to receive payment, though not the related DES concessions. Practices will be advised to stop vaccinating children under 5 from the end of March. The Joint Committee on Vaccination and Immunisation have suggested that the vaccine can now be offered as a travel vaccine for those travelling to Southern Hemisphere countries during their flu season. This is likely to be provided through private travel health

providers.

### **Impact of Budget 2009 on Pensions**

In his Budget on 22 April 2009, the Chancellor announced the introduction, from 6 April 2010, of a new additional rate of income tax of 50%, applying to taxable income over £150,000. In order to prevent this resulting in an increase to the tax relief granted on pension contributions, the Chancellor also announced that from 6 April 2011, tax relief on pension contributions for high earners will be restricted.

The BMA has produced a guidance note that looks at the changes to tax relief on pension contributions, along with the 'anti-forestalling' measures that the Government has put in place to limit individuals who may otherwise have been tempted to maximise their tax relief by making additional contributions before 6 April 2011.
