Cervical Cytology Training

Earlier this year, a number of PCTs were insisting that all GPs working in their areas undertake either a half day or a full day's update training in taking cervical smears. As a result of GPC intervention, the Dept. of Health (DoH) wrote to all PCTs on 15 December 2011 confirming that there is no contractual requirement for GPs to have cervical cytology update training.

The GPC view was this also applied to nurses, and the DoH has now confirmed that they agree with this interpretation as the letter is about the principles which apply to services provided as part of the contract, whether these services are provided by GPs or others employed by practices such as practice nurses.

Long term Conditions Case Management LES

The LMC have concerns that, despite the LES not

offering a profit buffer to practices, financial risks could remain with practices, relating to, for example, employment contracts; such as short term sickness cover, or other statutory reason to be away from work and the difficulty in finding short-term fixed-contract staff.

A further concern was also raised that this should not set a precedent of work being undertaken by primary care on a cost only basis. It was felt however that an attempt to recognise the transfer of work into primary care should be supported if possible.

Care Homes LES Pilot

The LMC Chairman noted correspondence received from Public Health at NHR relating to a pilot for six GP practices and Homes linked to high emergency admission rates; this followed pilot work at St Ann's. There then followed discussion amongst LMC Members about how and which six practices would be chosen and the contradiction of a self-selecting pilot within a LES regime. Concerns were raised around the open and contestable nature of this LES, a lack of consultation, and duplication with the case management pilot.

084 Numbers Again

Members discussed the front page article in the Rotherham Advertiser on 6th January regarding 084 numbers. John Healey MP was leading a local campaign highlighting the use of these numbers by Rotherham GPs. This issue had also been raised last year also by a national campaigner.

The accepted principle was that patients should not be charged more than the cost of a local call for contacting practices. However, members noted that, historically, all practices had been encouraged by the government to sign-up to 084 numbers with telecoms companies. Hence, as some practices had signed-up to long-term deals, there were significant capital costs in switching out of these contracts.

The regulations do not include any specific requirement for practices to consider the cost of calls from mobile phones. In terms of call tariffs, the call rates which patients are charged depend on their mobile phone service provider. It is a matter for individual members of the public to ensure that they are happy with the terms and conditions of the mobile phone arrangements that they enter into with their mobile phone provider.

Referrals

The NHSR Medical Director, Dr Plews, wishes to express gratitude for the work GPs have done regarding referrals – Rotherham Hospital NHS FT have noticed significant drops in referrals in the areas recently targeted.

Sessional GPs Group

Sessional GPs groups have been recognised as providing invaluable peer support for sessional GPs, with groups offering a range of services and benefits, including educational and social meetings, electronic mailings systems for vacancies and educational events. Models differ but there are some common themes and challenges.

Injury Benefits Review

The NHS has conducted a review of its injury benefits scheme, which currently provides benefits to GPs who suffer injuries and a resultant loss of earnings as part of their employment.

The outcome of the review is that the current Injury Benefit Regulations are to be replaced by contractual provision held within a new section of the Agenda for Change (A4C) Terms and Conditions Handbook.

Future injury benefit provision would be limited to the period of the employment contract only.
