## Updates

## PPG Network meeting 21<sup>st</sup> April attended by Helen Phillips and Nora Mzaoui

The meeting was Chaired by Mike Holdgate with speakers Suzanne Novak (CCG interim lead for primary care); Dr. Christa Beesley (CCG chief clinical officer and local GP); Jane Lodge (CCG engagement lead)

The meeting started with Suzanne Novak giving the presentation about the planned changes to primary care in the city. She introduced the talk by emphasizing the shortage of GPs, difficulties in recruitment and how we require 20 - 30 more GP's. She also mentioned that the situation is very poor compared with other areas and that, although under great stress already, GPs need to do still more. She stressed the importance of primary care and that it is good value for money for improving health. There was some discussion about factors that influence recruitment. including workloads, recruitment difficulties and limited health education among the public. One theme was about helping patients to access primary care more guickly and ways in which this is an equalities issue (the map of where GP practices are located is one illustration of this).

The Extended Integrated Primary Care Programme (EPIC) was described and discussed. Where it has been operating (16 practices) evaluations are favourable but funding will not continue. However, at least one aspect – the community navigators – will be continued in the participating practices. More info:

Another theme was how the CCG is supporting GPs to take more proactive approaches to keeping people healthier longer, in terms of mental as well as physical health. Nearly half the practices in Brighton and Hove have signed up to a national contract of enhanced services. This involves reviewing patients to identify the 2% most at risk of avoidable emergency admission to hospital and drawing up individual coordinated care plans for health and wellbeing. Questions were raised about the validity of the 2% target in every case, and about what is being encouraged to improve the lives of those who have debilitating conditions that are not related to emergency admissions to hospital. This part of the presentation was illustrated by figures from the recent local audit about premature mortality. The city has higher mortality rates among 18-74 year-olds than other parts of England and other parts of the South East, and the rate is not uniform across the city.

Another key point is that our CCG will promote patient participation at decision making level, and that PPGs will become the backbone of this representation, working within clusters of practices which will be encouraged to sign up to a local contract, "Healthier and Happier Brighton and Hove". It will be an 'outcomes orientated contract' with key outcomes such as: Improved detection of coronary heart disease, COPD and dementia;

Improved flu immunisation rate; Higher percentage of health checks for those living in the most deprived areas;

- More smokers quitting;
- Increased survival rates from lung cancer, breast cancer and prostate cancer;
- Reduction in under-75 mortality rates in adults with serious mental illness;
- Improvement in emotional health and wellbeing among children and young people.

The role of PPGs within clusters will be developed, possibly for autumn 2015. A GP's perspective about the changes was given by Dr Christa Beesley, who spoke enthusiastically about her belief in the potential power of patient involvement in their own health, and as PPG members.

The second part of the meeting included a talk by Jane Lodge about structural changes to the way in which patient and public opinions are made known to the CCG Board. A new committee, called Participation and Communications Assurance Committee or PARC, will be chaired by Mike Holdgate who is also Chair of the PPG network. It will include members from all organisations in the city where patients and the public have a voice so that all views can be brought together for consideration by the CCG. PPGs will be represented by two patients elected through the PPG network.

Healthwatch Brighton and Hove (HWBH) informed the meeting about imminent 'enter and view' visits to GP surgeries and that the relevant PPGs will be contacted in order to collaborate.

# PPG Network meeting 13<sup>th</sup> July 2015 – attended by Nora Mzaoui

The meeting was chaired by Mike Holdgate with speakers Kirsty Sibandze (NHS ENGLAND), Jennie Moore (Community Works/TDC) and Jane Lodge (CCG engagement lead). Also attending was Nicky Cambridge, Chief Executive Officer of Healthwatch.

The main point discussed at this meeting was the closure of Goodwood Court Surgery (GWC) and the take -up of their patients by Charter Medical Centre (CMC) and some surrounding surgeries.

Last month the CQC decided to close Goodwood Court Surgery due to unsatisfactory care for its patients. This meant the patients of that surgery were offered to be relocated to Charter medical Centre (especially the most vulnerable ones) as first choice however patients were given the choice to register somewhere else.

Our main concern as the Charter Patient Group and the wider PPG, as well as Charter patients, was the lack of communication around this matter. Although GWC patients received letters regarding the immediate closure of their surgery and the available options, patients The at CMC received none. only information available to Charter patients with regards to the changes was the information on the website and information on the display screen in the waiting area.

Another concern raised was around the **available resources and capacity** of CMC to accommodate the influx of new patients. Other PPG reps commented that their surgeries were inundated with patients from GWC (e.g. Wish Park

surgery and Sackville Road surgery) and were struggling to cope.

Lastly, we wanted to know what **procedures** are now being put in place to ensure situations like these will be handled more transparently in the **future**.

At the meeting Kirsty Sibanze, representing NHS England, was able to hear our concerns and respond accordingly. The following points of interest were made;

- This was the first situation in the whole country where the CQC decided to close a surgery with immediate effect.
- NHS England acknowledges that the situation wasn't handled very well and regrets the fact that Charter patients were not informed of the changes by letter (like the GWC patients).
- Both CQC and NHS England will take on our concerns raised to ensure this will not happen again in the future.
- In terms of capacity, CMC were allocated an amount of available appointments specifically for the GWC patients, however, so far not all appointments have been used. To deal with the increased numbers of patients the surgery didn't take on more GP's but increased the time slots available for appointments.

Although some of our concerns were not addressed properly, the matter will be continually monitored by Healthwatch who also raised concerns at the meeting

### EPIC trial to end:

One of the most important points to be made at the recent PPG network meeting this April was that the EPIC initiative (which has been operating out of Charter Medical Centre) is to end in November as funding has been withdrawn. 'EPIC' is a pilot scheme which has seen extended surgery hours – which benefitted not only Charter patients, but those from neighbouring surgeries. In a week which has seen David Cameron renew his preelection pledge to create a 7-day a week NHS, some might consider this move as somewhat misguided or at least at odds with current thinking.

Increasingly, working people in our community need access to healthcare at weekends and after hours during the week. Whilst appreciating it is a strain on current staffing resources, it does seem to have been a very popular move. Let's hope then, with adequate funding in place – and with the necessary staffing levels the CCG will be able to implement this system permanently.
