### **Dentists requesting advice from GPs**

It has recently come to our attention that increasingly dentists are contacting GPs, asking their advice on a patient's suitability for a tooth extraction or alveolar surgery. We liaised with the Local Dental Committee on this matter and they have advised us that this is due to the fact that there's been a lot of publicity about the potential danger of patients who are on Bisphosphonates. Dentists were instructed to contact their GPs for this information as patients are not always clear about how long they have been taking the drug.

While it is fine for GPs to be giving factual information, they should clearly not be expected to give advice on dentistry. We would remind GPs of the recommendation that a review by their dentist should be completed before a patient is commenced on Bisphosphonate therapy.

#### Letter templates for rejecting inappropriate requests to follow up hospital investigations

NHS England recently published "standards for the communication of patient diagnostic test results on discharge from hospital".



As noted by the GPC, principle two of the guidance is seemingly contradictory, stating *"that every test result received by a GP practice for a patient should be reviewed and where necessary acted on by a responsible clinician even if this clinician did not order the test"*. The wording could be interpreted to potentially add significant bureaucracy and workload onto practices. To counteract unnecessary work the BMA have recently developed the following templates, which you may find useful:
