Notes of the LMC Executive Group meeting which commenced at 6.37 p.m. on Tuesday, 14 December 2010 at 80 The Grove, Marton, Middlesbrough

Extreme weather conditions had caused the LMC Board Meeting scheduled for 7 December 2010 to be cancelled. The Executive Group met to discuss the Board Agenda items.

1 APOLOGIES

Apologies had been **RECEIVED** from Dr D Donovan, LMC Chairman.

2 MINUTES OF THE BOARD MEETING HELD ON 2 November 2010 (previously circulated)

DEFERRED to LMC Board Meeting on 11 January 2011.

3 MATTERS ARISING FROM THE MINUTES OF PREVIOUS BOARD MEETINGS

3.1 Minute 10/11/3.1 – A query has been raised over A random audit of 100 admissions at JCUH concluded that 75% of them had not been admitted by their GP and were inappropriate admissions by OOH, Darzi practices and A&E.

Clarification from Dr Lone had been sought, who said: "I informed the meeting that our practice had audited 100 consecutive discharges from JCUH and this showed that only 25% of patients had been admitted by GPs from the practice. 75% of patients had been admitted either by Darzi practices, the Out of Hours Service or via the A & E Department. As I did not have access to the records of patients who had not been admitted by the GPs it was difficult to ascertain whether they were appropriate or

inappropriate admissions. Twenty four of the twenty five patients admitted by the GPs were deemed to be appropriate."

DEFERRED to LMC Board Meeting on 11 January 2011.

4 WHITE PAPER UPDATE

The Secretary had attended a Pathfinder Workshop in Newcastle on 8 December organised by NE SHA. Discussion had taken place around the emergence of leaders and an assessment criteria as the people undertaking the Pathfinder role needed the requisite skills in order to perform the role.

The Medical Director had attended the NE SHA Regional Advisory Group in Durham on 9 December where they had looked at the support, leadership and management training needed. A number of private organisations were gearing up to provide such training.

In order to allow Tees GPs to attend local GP commissioning meetings, would it not be beneficial for PCTs to employ someone to step in and provide back-fill? The LMC needs to arrange a meeting in the New Year with all local consortia leads; Martin Phillips may have funding to allocate for backfill in order for these meetings to take place.

It was noted that the Langbaurgh Pathfinder was for GMS/PMS practices only and APMS practices will have to be slotted in somewhere. Hartlepool Intrahealth (APMS) had been slotted into the Durham Pathfinder as they are part of a confederation based in Durham.

5 OUT OF HOURS UPDATE (excluding APMS practices who already cover the period 6.00-6.30 p.m.)

The Development Manager was still querying prices with NDUC relating to the block contract for the clinical cover. As soon as the figures were clarified all practices would be notified (this did not include APMS practices who already worked 8.00 - 8.00 hours).

After discussion, it was **AGREED** that:

- the LMC would be recommending practices opt for full clinical cover with NDUC;
- practices wishing to opt-out of the full clinical cover should notify the Development Manager; no response would be taken as the practice wishing to opt-in to full clinical cover
- the LMC would organise and fund independent legal advice on the model contract for the 6.00 - 6.30 p.m. cover to ensure all Tees practices were adequately covered/protected. Practices would still need to sign individual contracts with NDUC.

6 IT SUPPORT

A letter had been received from a constituent lamenting the poor and inadequate quality of IT support practices currently receive from the PCT, and it was only likely to get worse as staffing levels reduced. It was felt that local consortia will have to join together to provide adequate IT support in the future.

7 DRAFT CHANGES TO CHILDHOOD IMMUNISATION SCHEDULING & INFORMATION HANDLING IN TEES

Communication from Dr John Nicholas, Caldicott Guardian

"It would be helpful if the LMC (or Executive Group) could indicate that it agrees that changes are necessary to improve child immunisation and the availability of immunisation data to health professionals involved in the care of a child e.g. health visitors."

After discussion, it was felt that as long as the PCT puts the information on the system, the request was something to be commended. It was **AGREED** that this decision would be conveyed to Dr Nicholas.

8 ANNUAL LMC CONFERENCE 2011

8.1 Thursday/Friday, 9/10 June 2011 The Mermaid Conference Centre, Puddle Dock, London EC4

Three representatives are allotted to attend the LMC Annual Conference, on behalf of Cleveland LMC. It is proposed that this should be the Chairman, Vice Chairman and Assistant Secretary/Medical Director. The LMC Development Manager will be attending as an Observer.

8.2 Honorarium and expenses payments for representatives at Conference

The Committee is asked to consider payments to representatives, which last year were:

- (a) £400 per day (subject to PAYE) or the actual costs for an external locum if greater, for the duration of attendance (locum invoice to be submitted to LMC office for payment); and
- (b) £50 out of pocket allowance per day (subject to PAYE if no receipts obtained); taxi payments to be taken out of this allowance. There was the expectation that attendees make a significant donation out of the allowance to the GP charity "The Cameron Fund" at the annual dinner.

9 TEMPORARY RELOCATION OF CHILD & ADOLESCENT MENTAL HEALTH SERVICES (CAMHS) LEARNING DISABILITY (LD) SHORT BREAK SERVICES FOR TEESSIDE

Communication from Paul Frank, Asst Director of Communication & Engagement NHS Tees

"As you may be aware, TEWV NHS Foundation Trust has provided the short break service from 179 Normanby Road, Middlesbrough and Piperknowle House, Stockton for a considerable number of years. Throughout this time the needs of the children and young people using the service have become increasingly complex, particularly over recent years.

The existing accommodation is now far from ideal to meet the needs of the children and often results in the service being limited or reduced. Due to the level of refurbishment required, the Trust is proposing to temporarily relocate the service to a new and purpose built single storey unit (The Baysdale Unit, situated at the front of the Roseberry Park hospital site in Middlesbrough), early in the New Year. The Baysdale Unit is available for a limited period of time (18 months) and will allow time for NHS Tees to carry out a full review regarding the longer term provision of CAMHS LD Short Break Services across Tees.

The Trust believes that this move is necessary in order that it can provide a high standard, safe and accessible service, something that is becoming increasingly difficult in the current premises.

15.4 Condition Management Programme

Communication from Ms Ali Wilson, Director of Commissioning & System Development (North)

"As you are aware since October 2005 NHS Hartlepool has hosted the Tees Valley Condition Management Programme (CMP) which is part of Jobcentre Plus *Pathways to Work* initiative.

Following this year's elections and the welfare system review, the new Government announced its intention to implement a single 'Back to Work Programme' for *all* unemployed people in the first half of next year. The new work programme has yet to be finalised but it will replace most of the existing welfare provision, which includes '*Pathways to Work*'. This means that CMP as it currently operates will cease. All NHS CMP provision will cease to be funded nationally on 31st March 2011 and NHS Hartlepool having received formal notice to this effect is currently in the process of winding down the programme.

We believe that the programme has been very successful locally, helping hundreds of people each year to manage their condition more effectively and supporting many back into work or study. The programme has been receiving an average of 130 referrals per month and 61% of these are between 25 and 49 years of age. Over 70% of all referrals have stated mental health issues as the prime reason for claiming incapacity benefit but whatever the reason these people have accessed a local individually tailored programme of support by highly skilled practitioners contracted to the programme and where appropriate have been referred into mainstream support services.

A full appraisal of the programme and final report is currently in preparation and will be forwarded to you in due course for your information.

We are particularly grateful for the contribution of Dr Gjertsen who on behalf of the LMC has been critical to ensuring the programme has appropriately linked into other services and has engaged effectively with local GPs.

On behalf of the Programme and NHS Hartlepool can I please therefore take this opportunity to thank the LMC for their support and ask that you bring this to the attention of your members."

The implementation of the new Agency will be phased between December 2010 and April 2011.
