1. Welcome and apologies

3. Matters Arising from the Minutes

Microbiology swabs – Jonathan has emailed Emma Watson again but has yet to receive a reply.

Durness – The Practices will be fully merged as soon as it is practical. There were no applicants for the post so Anne is working with a number of locums.

Clozapine Monitoring – Patients out with Inverness are no longer being seen in Raigmore. Argyll and Bute have an enhanced service and Clozapine is included in this. North Highland is looking at what can be done as there are 4 patients out with Inverness and they are looking at how a service can be provided.

Savings North and West – Susan had a reply from Gill McVicar about this. Apparently there has been an underspend in Primary Care. The changes in progress, have been to identify the underspend and cite it as a saving. LMC noted that in North and west OOH GPs are paid £18 per hour and advanced nurse practitioners get paid £28 per hour. Susan offered to share the information with Ishbel.

OOH Work - In Cowal OOH GPs are now been recognised as employees. Precedence was set in a case saying we should get the same terms and conditions when working OOH.

5. Update from other groups - for information

5.1 GP Reps/GP Sub – anything to report from the Chairman

- Midwife Vaccinations GPs in Inverness are not happy about the continued resistance of midwives to carry out vaccinations.
- Golden Hellos –There are 2 options to allocation: The first is that HHB sticks strictly to the guidance or alternatively to pay some sort of Golden Hello to all GPs starting their first substantive post. Elizabeth has been on Mull and she felt it would have been better if the Health Board ensured the house she was given and car she was given were appropriate. Paul Davidson agreed and felt that relocation packages may be more attractive. There are mixed views about Golden Hellos but they are seen as being attractive, though much is lost to tax, national insurance and pension. We Fiona, Ros and Joyce are meeting to agree on what they feel is the best way forward and this will be taken to the Technical Group.
- BMA Roadshow in Lochaber This was successful and more interactive as the IT worked.
- Vaccinations The process is becoming very complex. General Practice is showing its
 strength by managing these complex programmes. The true cost of the vaccinations is not
 reflected in what GPs are paid for it, and cost was agreed on the understanding that
 community staff would help administer. Some Health Visitors in Argyll and Bute carry out
 childhood vaccinations but they are now saying they do not have capacity and the service is
 threatened. This is against the national directive which requires the Health Board should offer
 at least the same amount of support.

Action: Sue will send Michael this information.

5.2 Chairman's Group Meeting 7th July 2015 and 4th of August 2015

GP Rep Numbers – As part of the new Committee the Chairs Group will review the rep numbers and there does not seem to have been a formulaic way that the decision was made.

- IT The response we wanted on premises was not achieved but it has been helpful.
- Interface work There has been a meeting of a group from the Scottish Colleges to discuss interfaces and this was interesting and worthwhile.
- Replacement of QOF This is going to be professionally led and based on outcomes.
- **OOH Review** Trying to get commitments from the 3 main parties before the elections next year.
- Faculty AGM 23rd September Amanda Howe is giving Talk in Fairways house.

5.4 SGPC – June Update Attached

lain spoke to this:

- New Contract This will be in place by April 2017. There is still little detail available.
- Paracetamol
- OOH
- Scotland's National Clinical Strategy
- **Primary Care Fund** there will be a Programme Board and General Practice can apply for funds through the Health Board.
- Possible disbandment of LMCs It is not clear what relationship LMCs will have with the
 proposed 'cluster' groups of GPs. General Practice still needs the LMC as a representative
 structure.
- **GP Training Posts** Only 78% of posts have been filled in Scotland
- **Drug shortages** Pharmacists can give alternative but similar drugs if there is a shortage without GPs having to re-prescribe.

Lorien has kept details so she has information about the bombardment of transfer of work and we have to get better at saying no.

There are two themes running through Lorien's examples

- Junior house officer type tasks chasing results etc.

Lorien wonders if we should collect more examples and Janet has lots of examples from East Sutherland. We agreed to look at the template BMA letters re unresourced work and look at sending out to GPs

Action: Sue and Lorien to draft letter for constituent use.

The Labs are updating their system and any solution to the lab interface problems would be complex. It might be worth asking Elaine Mead to do an RPIW on this.

ISD have just published waiting times in Scotland and NHS Highland is the worst in Scotland 2 Locum Orthopaedic consultants have just been appointed to help this.

10.2.1 GPs to Chase and Refer

- 1. GPs are being asked to chase results of tests which have been requested in hospital. This should be the job of the responsible consultant and not the GP. This issue was addressed within Rod Harvey's letter.
- 2. Patients are being asked to attend their GP following an abnormal finding at pre-op clinics e.g. positive urine dipstick, abnormal ECG. Is this really the job of the GP or should it be sorted out by the pre-op clinic? UTI we have raised this with Orthopaedics already
- 3. On 1 occasion a GP has been asked to refer a patient onto cardiologist, by the pre-op clinic, due to admitting to experiencing chest tightness on exertion. The GP felt the referral should have been done by the pre-op clinic. Paul Davidson's response on the SBAR was very reasonable.
