Refer: as appropriate, ensure that someone who can support is aware of your concerns





#### **EARLY HELP**

Providing early help is more effective in promoting the welfare of children than reacting later.

- Early help means providing support as soon as a problem emerges, at any point in a child's life, from the mother's pregnancy (help for the unborn child) through to the teenage years.
- Early sharing of information is the key to providing effective early help.

Clinical commissioning groups and the NHS are subject to Section 10 of the Children Act 2004, hence so are GPs who have an important role in identifying families where issues are emerging and ensuring that they are given the support within primary care if possible or encouraged to access help

The new Early Help delivery model has been developed through our multiagency Children Trust Partnership and came into effect 2019.

- There are 3 new locality Early Help teams based in Bury, Radcliffe and Whitefield and support all five neighbourhoods
- The teams are working with children and young people, age 0-19, and their families
- The teams are linked to the schools, so that every school in the borough has an Early Help contact
- Similar pathways to support are being developed for pre-school children and post-school
- The Early Help teams link with partner organisations to ensure a joined-up approach
- A new Early Help assessment, the Story So Far, replaces the previous Early Help Family Support Plan and is already being successfully used by schools and other agencies



#### **LADO (LOCAL AUTHORITY DESIGNATED OFFICER)**

#### Allegations against professionals/volunteers that work with children

All allegations about people who work with children, in statutory, independent or voluntary organisations, must be referred to the Local Authority Designated Officer (LADO).

A referral to the LADO **must** be made if there is information about a person indicating they have:

- Behaved in a way that has harmed a child or may have harmed a child;
- Possibly committed an offence against or related to a child;
- Behaved towards a child or children in a way that indicates they may pose a risk of harm to children;
- Behaved or may have behaved in a way that indicates they may not be suitable to work with children. \*

\*This is new supplementary guidance and will be being sent out to Primary Care about this.

If there is an allegation about someone who works with children about children, they care for in another capacity then this potentially has implications for their professional role and must also be referred to the LADO.

Any allegation can require potentially three different enquiries; a police investigation; a child protection enquiry; and a disciplinary enquiry. The LADO will ensure that enquiries are managed appropriately and that information is shared between the police, children's social care and the employer. The LADO will discuss with the employer how the person who the allegation is about will be supported and managed whilst enquiries are being undertaken and how children will be kept safe whilst enquiries are ongoing. If it is evidenced that someone is unsafe to work with children the LADO will ensure required actions have been taken including, when necessary, referring to the Disclosure and Barring Service.

On occasions someone who works with children can behave in a way that causes their colleagues or management anxieties. Such behaviours may include the failure to understand or appreciate how his or her own actions or those of others could adversely impact up on the safety and wellbeing of a child; inability to make sound professional judgments which safeguard the welfare of children; failure to understand or recognise the need for clear personal and professional boundaries in his or her work; behaved in a way in his or her personal life which could put children at risk of harm; become the subject of criminal proceedings not relating to a child.

Anyone with concerns about a person's suitability to work with children should contact the LADO for advice and guidance.

#### MAKING A REFERRAL

If a member of staff has concerns that a vulnerable person is being drawn into terrorism or terrorist related activity, for both adults and children they should seek advice from the CCG Safeguarding Team as to whether the information should be shared.

If you have concerns about an individual, you can make a referral into Prevent. To do this simply fill out the correct referral form and send it to the following email addresses:



#### **FABRICATED OR INDUCED ILLNESS (FII)**

Since the publication of the Royal College of Paediatrics and Child Health (RCPCH) guidance on Fabricated or Induced Illness by Carers (FII) in 2009, there have been significant developments in the field. The RCPCH Child Protection Companion 2013 extended the definition of FII in 2013 by introducing the term Perplexing Presentations with new suggestions for management. This new guidance provides procedures for safeguarding children who present with perplexing presentations and FII and offers practical advice for pediatricians on when and how to recognise it, how to assess risk and how to manage these types of presentations in order to obtain better outcomes for children.

If you remain concerned or have heightened concerns, you should discuss the child with the safeguarding team within the CCG. If concerns remain, then the child should be discussed with relevant health professionals. At this stage the concern about possible FII **should not** be disclosed to the parent/carer.

#### **INFORMATION SHARING**

GPs have a responsibility for raising concerns, sharing information, and working together with statutory agencies to contribute to the 'early help', 'child protection' and 'child in need' processes. General Practitioners are increasingly asked to supply clinical information for safeguarding reasons. Appropriate information sharing is vital to protect children, and failure to share information in a timely and appropriate manner has often been identified when children have been significantly harmed.

#### **CONSENT**

As a rule, in safeguarding children, consent is not required for Section 47 referrals where a child is considered at risk or is thought to have suffered significant harm. Nevertheless, if undertaking a referral to social services, consent should be sought unless to do so would increase harm to the child. If social services request information, then this should be provided for all section 47 and section 17 referrals. Section 17 referrals are usually made with parent/carer consent, but consent is not required in cases where failure to share information could result in the situation deteriorating. However, for Early Help, consent would be required unless failure to provide early help would result in risk or harm to child. Given the statutory framework and very clear guidance on the requirement to share information, there is a clear understanding that there would need to be very good reasons not to share relevant



information. Remember that some children have come to harm due to a lack of information sharing, but none have been harmed because information has been shared.
