## Intention to merge Marple Cottage Surgery and Guywood Practice, Romiley

We are writing to inform our patients that we are planning to merge with Guywood Practice in Romiley. Over the last 12 months both practices have been working together and have supported each other during the pandemic. We are now ready to formally merge into one Practice contract.

## Why are we merging?

As you know we have worked hard to provide high quality services for our patients, always focusing on providing good access to appointments and continuously seeking to improve.

We have consistently demonstrated high quality clinical care in our prescribing, vaccination and screening achievement, alongside good appointment access and patient satisfaction, all of which has been recognized when we were awarded an Outstanding rating by the Care Quality Commission.

However, we have learnt through the pandemic that to continue to develop and improve our standards of care and access we need to improve the resilience of service provision for our patients.
